ILAC Resolution GA 28.01

The General Assembly accepts the Minutes of the 27th meeting of the ILAC General Assembly, held on 13 and 15 November 2023 in Montréal, Canada, as a true and accurate record of the meeting.

Draft Resolutions for IAF and ILAC at the 22nd IAF-ILAC Joint General Assembly

9 October 2024, Berlin

JGA Berlin Resolution 1 – Establishment of Global Accreditation Cooperation and Appointment of Officers

The Joint General Assembly, based on the positive ballot results of the Global Accreditation Cooperation (GLOBAC) Constitution and General Rules, endorses the recommendation of the Joint Executive Committee to establish GLOBAC with the following body corporates: ISRAC, ACCREDIA, ema, and ANAB. It also agrees to appoint the ILAC Chair, IAF Chair, IAF Vice-Chair, ILAC Vice-Chair, IAF Secretary, and the IAF Treasurer as officers of GLOBAC, as required for its legal registration in New Zealand.

JGA Berlin Resolution 2 – Continuation of the Development of Global Accreditation Cooperation (GLOBAC)

The Joint General Assembly endorses the recommendation of the Joint Executive Committee that the Steering Committee, reporting to the Joint Executive Committee, continue with the development of GLOBAC. A contractor will be engaged for this project, with costs shared equally by IAF and ILAC.

JGA Berlin Resolution 3 – Strategic Plan for the Global Accreditation Cooperation (GLOBAC)

The Joint General Assembly endorses the recommendation of the Joint Executive Committee that the IAF and ILAC Vice-Chairs will propose the process for the development of the initial Strategic Plan for GLOBAC.

JGA Berlin Resolution 4 - Renewal of OIML-ILAC-IAF Memorandum of Understanding (MoU)

The Joint General Assembly welcomed the renewal of the tripartite Memorandum of Understanding (MoU) between OIML, ILAC, and IAF.

JGA Berlin Resolution 5 – Acknowledgment of Reports from External Organisations
